Welcome

The meeting was opened by the Chairman Peter Hegarty at 14:12. A warm welcome was extended to those present and the Chairman thanked all for their attendance.

Minutes

The Secretary read aloud the previously circulated minutes of the previous AGM held on 20th January 2019. Donald Roberts PROPOSED that they be confirmed and adopted as a true and accurate record. This was SECONDED by Malcolm Warren and PASSED by those present.

Treasurers Report for the Year ending 30th September 2019

As in previous years, the Accounts presented include pledges and expenses from the previous year as they could not be realised in the accounting period in which they actually occurred. Donations from Lodges in all Provinces continues to increase. However, the anticipated donation from the Province of West Lancashire was not received during the Accounting Period. As a consequence, income was marginally down (3.3%) on the previous year.

Expenditure increased more than 3 fold – from £14,560 to £55,845.

The sum of £21,000 was voted over to the Residents Amenities Fund. A substantial increase on the previous year (£9,250).

The overall increase in outgoings was also due to the introduction of the Nordoff Robbins Music Therapy programme, funding of soft furnishings for all 50 bedrooms (£300 per bedroom) and the provision of a special bath with lifting facility (£6k). None of this was covered in the £500k RMBI refurbishment.

The fund remains in a healthy condition, sitting at £48,064 at the end of the Financial Year, and there should be no cause for concern.

Accounts for the Year ending 30/09/2019 were circulated and presented by the Treasurer. Eric Bailey PROPOSED and Phil Wrotchford-Thomas SECONDED that they be accepted. This was PASSED by those present.

The Chairman thanked the Treasurer for his continued hard work.

Report on behalf of the Association 2019 (Secretary)

Once again, the Association and Ecclesholme have had a busy and financially rewarding year. Most of the donations by the Association have been used in providing social and personal activities and therapy to the Residents of Ecclesholme, to pay for regular entertainers and therapists, and to enrich the level of comfort and engagement for all.

The Summer Fair was opened by the Provincial Grand Master for Cheshire R.W.Bro. Stephen M Blank and the Christmas Fair was opened by the Deputy Provincial Grand Master of East Lancashire V.W.Bro. John R Farrington. Both speakers were warmly welcomed at the events by our President and Chairman and both guests enjoyed their afternoon with us. The Association extends its thanks to them both and their partners for their kind attendance and support. The fairs were reasonably well attended, and both generated a healthy amount of money.

This year's Gala Dinner at Widnes Masonic Hall was well attended and a great success. The Association extends it's appreciation and thanks to the Widnes Group for hosting the event and their diligent efforts in organising what was a very successful and most enjoyable evening. It was a pleasure to receive our Patron R.W.Bro. James Anthony Harrison Provincial Grand Master for West Lancashire and his wife Maureen as the Principal Guests on the evening. A very kind toast to the Association was proposed by the Assistant Provincial Grand Master W.Bro. Kevin Peter Poynton. The Association thanks them all for their attendance and support.

During 2019 the Residents Amenity Fund received donations of £39,000.00 from the Association, helping to fund the following projects and activities:

- Curtains and fixtures for all 50 bedrooms in the home
- Podiatry services
- Musical health therapy

- Travelling Zoo Lab
- Miscellaneous entertainments
- Summer 'Tiki bar' BBQ
- Activity items
- Provisions for the Festive Season and New Year

The Association continues to receive very significant donations from the Provinces of West Lancashire, East Lancashire and Cheshire through their respective charities. We express our most grateful thanks for their generosity and continued support.

Donations from Lodges, Chapters and other orders remain strong and we are once again indebted to them and everyone who gives so generously to our cause. Included amongst these donations are the generous support we receive from the West Lancashire Masonic Bowling Charity and the extraordinary donation of £1,500.00 from St Oswald Lodge No. 5170 (on surrendering their Warrant).

Thanks must go to our Ladies, our Association Officials, Eccles Masonic Hall and all who have played a part in supporting the Association and its fund raising activities.

On a final note, a very big thank you to the Home Manager Beverley Niland, her Deputy and all her staff who work so tirelessly, not only in ensuring the residents are well cared for and motivated but, more importantly in making them feel they are valued and a part of the family. Their diligence and compassion makes the care they give to our residents second to none.

The Chairman expressed thanks to the Secretary for his diligent hard work.
